Annoucement about order

The Buyer – Gdansk University of Technology, acting on the basis of art. 4 paragraph 8 of the Act On January 29, 2004, Public Procurement Law (Dz. U. of 2017. Pos. 1579), informs about the intention to award the contract for **2 items Graphics processing unit** for the Faculty of Electronics, Telecommunications and Informatics Gdansk University of Technology and invited to make offer.

1. A detailed description of the order:

The order is for delivery

- 1 piece of UR-F1 FIXER 10 L CONC,
 - 1 piece of QR-D1 DEVELOPER REPLENISHER 10 L CONC,
- specified in Appendix 1.

The Buyer requires that the object of the contract is brand new, free from all defects and damages, without prior use, not an exhibition item, and can not be subject to the rights of third parties.

2. The offer should include:

- a) subject of the order
- b) gross price for the order including all costs necessary to complete the order, including the price of goods, transport costs to the buyer, in PLN;
- c) the order due date
- d) offer validity.

3. Description of the method of calculating the offer price:

- a) offer price is the price specified on the form "Bid form" (Appendix 2);
- b) the offer price must be determined in the gross value (including VAT), calculated to two of decimal places;
- c) for offers in a currency other than PLN, the offer price will be converted into PLN according to the exchange rate from Table A of Narodowy Bank Polski, from the date set as the deadline for submission of offers;
- d) offer price should be calculated taking into account all the costs necessary for the proper execution of the order, including in particular: the purchase price of the contract, the cost of transport to the buyer office, warranty, any customs duties, packaging costs, insurance costs for the period of transportation to the Buyer

4. The offer must be submitted (on the enclosed form) until 2017.11.10, till. 10:00 A.M. local time in Gdansk, in written form to Gdansk University of Technology Faculty of Electronics, Telecommunications and Informatics, 80-233 Gdańsk, ul. G. Narutowicza 11/12, WETI Building A, room 116 or to e-mail address: logistyka@eti.pg.edu.pl specifying in the title of mail: ZZ/960/009/2017. Tenders submitted in electronic form shall be attached to email as a

scan of the original documents (original absolutely must be signed by person submitting the offer). The Contractor may request the Buyer to clarify the contents of the announcement by sending inquiry to e-mail: logistyka@eti.pg.edu.pl.

5. Criteria for order evaluation of tenders

Evaluation criteria: price – 100%

The Buyer will award the contract to the Contractor who submits the complete offer and the lowest price. If two or more offers are submitted at the same price, the Buyer shall call these Contractors, to submit additional tenders on the specified terms. Contractors which submitting additional tenders can not offer prices higher than in the previous offers.

6. The Buyer reserves the right to cancel the procedure at any time without giving reasons.
